

NORTHERN RAILWAY**NOTICE**

Application on prescribed Proforma from the categories of retired Station Masters, Train Clerks (TNC), Gatemen and Pointsmen are invited for re-engagement in all the Divisional office of Northern Railway on remuneration basis for a period of 1 year or till filling up the vacancies, whichever is earlier. This is underlined that the selected incumbents can/shall be posted any where under the geographical jurisdiction of concerned Divisional office of Northern Railway. The scheme of the re-engagement is valid up to **14.09.2018**.

- 1. Who are eligible to apply:**
- a) Retired Railway employees from Station Master Cadre, Train Clerks, Pointsmen and Shunting Master within the age limit of 62 years who are desirous and fit to work on daily remuneration basis.
- b) The maximum age limit for such re-engagement shall be 62 years of age and or 14.09.2018 whichever is earlier. This limit shall not be exceeded during the period of engagement.
- 2. The daily allowance shall be as follows:**

The daily allowance + full pension should not exceed the last pay drawn at the time of retirement.

- 3. Period of Engagement:**
- a) The present scheme of re-engagement of retired employees is up to 14.09.2018 unless extended further by Railway Board. Those re-engaged during this period shall continue up to the last day of the month in which he attains age of 62 years i.e. following the same system as that of normal retirement.
- b) All the re-engaged staff will be discharged from engagement immediately after availability of suitable replacement.

- 4. Whom to Apply:**
- a) • The Divisional Railway Manager (P), Northern Railway, Firozpur latest by 14.05.2018 through registered post only. Name of the post applied for should be clearly mentioned on envelope. The administration shall not be responsible for delay of the Dak.
- The applications sent to H.Qr office will be summarily rejected.

The selected candidate must mandatorily obtain medical fitness required for the posts before re-engagement as per Railway Board's guidelines issue vide L/No.E(NG)II/2010/RC-4/6 dated 13.01.2011 circulated under PS No. 13770/2011.
